The board

took a recommendation to bump contingency from \$50k to \$75k. Sandy moved to approve the draft budget, with this change, Erin 2nd, **Vote 5-0** in favor.

b. Operating Budget: There was discussion regarding a new salary scale and staffing plan proposed by Kara. Kara and the board agreed to the salary and wages amount in the draft budget. Bill moved to approve the 2020 operating budget, Brian 2nd, **Vote 5-0** in favor
